



## Direct Entry Pre-Approval Requirements

Policies for the Direct Entry program can be found in Section 9 of SPRAT's [Rope Access Evaluation Guidelines](#).

### Eligibility

- SPRAT's Direct Entry program allows individuals who have obtained rope access experience outside of the SPRAT certification program to evaluate at an upper-level SPRAT certification
- Individuals who hold or have held a certification in one of the following recognized rope access associations may apply for approval to evaluate as a Direct Entry candidate as per the eligibility requirements:
  - Australian Rope Access Association (ARAA)
  - German Association for Rope Access (FISAT)
  - Industrial Rope Access Trade Association (IRATA)
  - IRATA Brasil *Associação Comercial de Acesso por Cordas Industrial* (IRATA Brasil)
  - Norwegian Association for Rope Access (SOFT)
  - Singapore Rope Access Association (SRAA)
- The Evaluations Committee will consider other rope access certification schemes following a review of their certification requirements.
- The following table provides a summary of eligibility requirements for Level 2 and Level 3 Direct Entry consideration:

Recognized organization level		Direct Entry L2	Direct Entry L3
(current or expired)	1	≥ 6 months, ≥ 500 hours as L1	<i>Not eligible</i>
	2	≥ 500 hours	≥ 6 months, ≥ 500 hours as L1, ≥ 1000 total hours
	3	≥ 500 hours	≥ 1000 total hours

### Application Process

- Applications must be completed in their entirety for committee consideration.
- Applications may be submitted by the individual, the Evaluation Session Host, or training provider.
- Applications and application fees should be submitted no less than five weeks before the scheduled rope access evaluation.
- Notice of an application's approval or rejection is sent to the Evaluation Session Host listed within the application.
  - This notice, as well as experience documentation, shall be presented to the evaluator at the beginning of the rope access evaluation. Additional confirmation may be provided by the SPRAT Office upon request.
- A candidate is ineligible to test at their preferred level without notice of Direct Entry approval from the SPRAT Office.
- Approval to test as a Direct Entry candidate is valid for two attempts.
- If a candidate is unsuccessful following two attempts, a new application must be submitted.

### Application Fee

- A non-refundable \$300 application fee is assessed at the time of application submission.
- This fee does not cover any candidate fees associated with an evaluation session .
